VI. Review and Approval of Resolutions for this Public Meeting

The following Resolutions may be adopted at this Public Meeting:

(**Tab 6**) Resolved, that the Louisiana Stadium and Exposition District ("LSED") hereby authorizes, approves, and ratifies the execution of the Master Plan Phase 3b Guaranteed Maximum Price Adjustment No. 28 ("Phase 3b GMP Adjustment No. 28") to the Guaranteed Maximum Price for the Construction Manager At Risk Contract by and between the LSED and Broadmoor, L.L.C. with respect to Phase 3b of the 2019 Superdome Capital Improvements Project ("Project"). Phase 3b GMP Adjustment No. 28 provides for a Request for Change Markup in the amount of \$30,931.25 to the Phase 3b Guaranteed Maximum Price and consists of the following:

The Phase 3b GMP Adjustment No. 28 has been reviewed and approved by the Master Plan Project Team, consisting of representatives of the LSED, ASM Global, and the New Orleans Saints, L.L.C., the Project Manager ("Legends Hospitality"), the Project Architect ("Trahan Architects"), and by LSED Counsel. The signature of Chairman Robert A. Vosbein, Jr. and/or Vice Chair Hilary Landry is hereby authorized, approved, and ratified.

- (Tab 7) Resolved, that the Louisiana Stadium and Exposition District ("LSED") hereby authorizes and approves an Insurance Portfolio Review by HUB International Gulf South, consistent with the attached Proposal, for a full and complete review of the LSED's coverage limits, terms, conditions, and endorsements; to assess the LSED's Risk Management protection; to identify any gaps in coverages; and to make any recommendations of adjustments to or for additional coverages. The total not-to-exceed expenditure for the LSED is \$15,000. The source of funding is the LSED Operating Account, and there are sufficient funds to support the Agreement and the Resolution. The Chairman and/or Vice Chair of the LSED are authorized to sign any necessary Agreements with HUB International Gulf South to facilitate this Insurance Portfolio Review, which signature is hereby ratified.
- (**Tab 8**) Resolved, that the Louisiana Stadium and Exposition District ("LSED") hereby authorizes, approves, and consents to the expenditure of funds for a documentary of the Superdome's 50th Anniversary. The funding source will be the Marketing and Promotional Budget as part of the LSED's Operating Account for a not-to-exceed sum of \$189,000. There are sufficient funds to support the Resolution. Upon approval by LSED Legal Counsel, the LSED hereby grants its consent for ASM Global to enter into an agreement with FatHappy Media, LLC., by providing a deposit for the documentary process to begin.
- (**Tab 9**) Resolved, that the Louisiana Stadium and Exposition District ("LSED") hereby authorizes and approves the execution of an Agreement with ME Engineers to conduct a Superdome Assessment that will include a review, study, and assessment of the mechanical systems, electrical systems, plumbing, and fire protection systems consistent with the attached Agreement for a not-to-exceed sum of \$51,000. The LSED consents to ASM Global to serve as the contracting party with ME Engineers. The funding source for the facility assessment will be LSED Operating Funds, and there are sufficient funds to support the Agreement and this Resolution. The Agreement has been reviewed and approved by LSED's Legal Counsel. Pursuant to this Resolution, the LSED grants its consent to ASM Global to enter into this Agreement.
- (Tab 10) Resolved, that the Louisiana Stadium and Exposition District ("LSED") hereby authorizes and approves the following agreements (i) Second Amendment to Cooperative Endeavor Agreement by and between the Louisiana Department of Transportation and Development ("DOTD") and the LSED, and (ii) Second Amendment to the Cooperative Endeavor Agreement by and between the Louisiana Department of Health Office of Public Health Bureau of Emergency Medical Services and the LSED. The primary purpose of the each of the Second Amendments is to assure the use of certain designated portions of the parking facilities at the Shrine on Airline (6000 Airline Drive, Metairie, LA) for use during emergency operations and for the protection of citizens of Jefferson Parish and the Greater New Orleans Metropolitan Area in the event of Declared Emergencies. Each of the Second Amendments has been reviewed and approved by Legal Counsel for the LSED. Chairman Robert A. Vosbein, Jr. is hereby authorized to execute each of the Second Amendments on behalf of the LSED.
- (**Tab 11**) At the March 27, 2025 LSED Board Meeting, SignWorx, LLC was awarded the contract for the Marquee Renovation Project at The Alario Center.

Resolved, that the Contract between the LSED and SignWorx, LLC signed by the Chairman is hereby ratified and the Chairman is hereby authorized to sign the Notice to Proceed so that the Marquee Renovation Project work can begin. This Resolution has the approval of Legal Counsel. A copy of the Notice to Proceed is attached to and made a part to this Resolution.

(**Tab 12**) On February 20, 2025, the LSED executed a Change Order to the Ratcliff Construction Contract ("Change Order 14") to extend the Substantial Completion Date of the John Alario Jr. Sports Complex Project to September 30, 2025. In order to align the Warranty on the Food Service Equipment with the Date of Substantial Completion, there is a need to approve Change Order No. 4 to the Trimark Food Service Contract. Change Order No. 4 will assure that the Food Service Equipment Warranty matches the overall Project's Construction Warranty so that the Owner of the facility will have a full 1-year Warranty that extends beyond the Project's Substantial Completion Date.

Resolved, that the Louisiana Stadium and Exposition District ("LSED") hereby authorizes and approves Change Order No. 4 to the Contract with Trimark USA Strategic Equipment, LLC, thus extending the Food Service Equipment Warranty for a full year beyond any Substantial Completion Date, through and including October 31, 2026, for an increased cost of \$5,450. The funding source is the Project Budget, and there are sufficient funds available to support Change Order No. 4 and this Resolution. The Resolution has been approved by the Construction Committee and has the recommendation of Legends as Project Manager. The Change Order has been signed by the President of Trimark. This Resolution authorizes, approves and ratifies the Vice Chair's signature on Change Order No. 4, with recordation to follow in the Public Records of Jefferson Parish.

(**Tab 13**) Resolved, that, pursuant to previously authorized and duly enacted Resolutions by the Louisiana Stadium and Exposition District ("LSED") Board of Commissioners, the following described agreements, contracts, change orders, and/or GMP adjustments ("Documents") have been executed by Chairman Robert A. Vosbein, Jr. and/or Vice Chairman Hilary H. Landry on the respective dates as shown on each Document and/or signed at or following the March 27, 2025, Board meeting:

- a) All Tax Exemption Certificates signed by Chairman Vosbein since the March 27, 2025, Board meeting;
- b) All Change Orders signed by Chairman Vosbein or Vice Chair Landry since the March 27, 2025, Board meeting;
- c) The Construction Manager at Risk Contract between the LSED and Broadmoor, L.L.C. for the Shrine Airline Conversion Project, as signed by Chairman Robert A. Vosbein, Jr.; and
- d) The AIA B105-2017 Standard Short Form of Agreement by and between the LSED and Duplantis Design Group, PC (DDG) pursuant to which DDG will perform surveying services and other professional services related to the re-subdivision of the real property whereon the Westwego Sports Complex aka the John Alario Sports Complex is located.
